**LETTER OF AGREEMENT FOR USE OF THE TURNING TARGET BAY IN RESERVE RANGE AREA**

This letter of agreement shall be between the Rogue Valley Shooting Sports Association (RVSSA) and the Reserved Range Turning Target Bay (TT Bay) user known as \_\_\_\_\_(User).

This agreement is for single day reservation use of TT Bay of the Reserve Range. The agreed upon details are listed below:

- User must have Reserve Range Credentials as described in other Reserve Range use requirements.
- User must have a pre-arranged reservation time authorized by RVSSA.
- User must have a trained supervisor that has been trained in the proper use of the equipment utilized at TT Bay. This person will be the responsible person for the User.
- User will be held financially responsible for any unnecessary or excessive damage done to the equipment and surroundings of TT Bay.
- User should provide their own uprights and targets to be used in TT Bay.
- User must obey all Reserve Range rules as they are noted in other agreements.

The agreed upon user fees of TT Bay are as follows:

- User agrees to pay RVSSA a User fee of \$ 100.00 per day.
- User agrees to pay a Shooter Fee of \$ 1.00 per shooter per day.
- User agrees to inform RVSSA of # of shooters within 2 days of completion.
- User agrees to pay for any excess damages as determined by RVSSA should there be any found.
- User agrees to be timely in payment of any and all Fees or billings pertaining to TT Bay's use. This timely period shall be agreed to be paid within 30 days of Use and/or Billing date.
- User agrees that the User fee of \$ 100.00 is expected to be paid, if reservation is not cancelled prior to 7 days of date reserved.
